The defendant's motion to dismiss Count Two (Mail Fraud) as barred by the statute of limitations is denied. 4. The defendant's motion to dismiss Count Three (Wire Fraud) as barred by the statute of limitations is granted. 5. The defendant's motion to dismiss Count Twelve and question one from Count Fourteen is granted in part and denied in part. Specifically, questions one and three from Count Twelve are based on fundamentally ambiguous questions and are dismissed. Question two from Count Twelve and question one from Count Fourteen may serve as predicates for the false statement charges. 6. The defendant's motion for severance is granted.
