This is with respect to a Holocaust Claim fund which has long received approval for immediate release. Be very aware that from special Master files the Proposed Plan of Allocation and Distribution of Settlement Proceeds, a two-volume document approximately 900 pages in length, including annexes and appendices; summaries are mailed to all 580,000 persons who returned Initial Questionnaires. Very important; I know you are not the owner of the fund, my contact with you is as a result of my search with the last name of the deceased owner of the fund which is the express ticket that is most valuable to the success of this pursuit.
